## **ADVISORY**

### **SUBMISSION OF AIRLINE SECURITY PROGRAMME**

#### **1. AUTHORITY**

This circular is issued by the Executive Chairman of the Instituto de Aviação Civil de Moçambique (IACM) in pursuance of powers vested in him under Article 31 of Law N<sup>o</sup> 21/2009 of 21 September and Article 12 of Resolution 19/2011 of 30 November.

#### **2. PURPOSE**

This Advisory Circular (AC) provides guidance for development of the Airlines Operations Security Programme in support of the National Civil Aviation Security Programme for prevention of Acts of Unlawful Interference. The standard format of the development of this Manual can be found either in IATA Security Manual or ICAO Doc. 8943 – Security Manual.


#### **3. DOCUMENTARY SECURITY REQUIREMENTS FOR AIRLINES OPERATING IN AND OUT OF MOÇAMBIQUE AIRPORTS**

- 3.1 Additional to the stipulated requirement for submission of the Air Operator Certification Documents, the Instituto de Aviação Civil de Moçambique requires all airlines operating to and from Moçambique Republic to submit two copies of Airline Security Programme for review and approval.
- 3.2 Under this requirement, the concerned Air Operator will be expected to undertake a review of the same Programme to ensure for its accuracy, adequacy and operational compatibility with the ICAO standard format as set forth in the relevant appendices to ICAO Doc 8973 before submission for approval.

Note:

- a) *One copy of the approved Programme will remain with the Instituto de Aviação Civil de Moçambique while the Operator retains the other.*
- b) *The Programme will be valid for two years unless significant changes in the National Civil Aviation Security Programme necessitates any change.*
- c) *Submission of two copies of the Airlines security Programme will be a mandatory requirement in future before any (AOC) Certification process is completed.*
