## TRANSFER OF AERONAUTICAL INFORMATION PUBLICATION (AIP) TO AEROPORTOS DE MOÇAMBIQUE, E.P.

#### 1. AUTHORITY

This advisory circular is issued under the authority of the chairman of the Instituto de Aviação Civil de Moçambique (IACM), in pursuance of powers vested in him under nr.01 of Article 31 of Law 21/2009 of 28 September and point g), Article 12, the Resolution 19/2011 of 30 November

#### 2. BACKGROUND

Whereas the IACM carries on business as Aviation Regulatory Body, competing in general, administer Civil Aviation in accordance with the principles and standards provided by the convention on International Civil Aviation and its annexes, the Aeroportos de Moçambique E.P. (ADM, E.P) has as its main objective to establish and explore public services of air navigation support and air traffic control, observing national regulations and international civil aviation standards. Under the memorandum of Understanding signed between the IACM and the ADM, E.P. which aims to transfer to ADM the Aeronautical Information Service provider functions. Therefore this Aeronautical information Circular is to formalize the effective transfer of the Aeronautical Information Publication Manual (AIP) from IACM to the ANSP- ADM, E.P.

#### 3. OBJECTIVE

To announce the transfer of the aeronautical information Publication Manual (AIP) from the IACM to ADM, E.P.

#### 4. ADVISORY

- 3.1. The air operators and the public in general are advised that the ADM, E.P. has the responsibility to publish and keep updated all the aeronautical information contained in the aeronautical information Manual (AIP) for the Beira FIR as from December 15, 2015.
- 4.2. In the first phase of this transfer, the ADM, E.P. will process the AIP in the same layout as edited by the IACM, while preparing the fourth edition of the AIP Mozambique, with effective date of publication scheduled for March 31, 2016.
