**ADVISORY**

**INTERNATIONAL AIRPORTS CERTIFICATION TEMPORARY EXEMPTION**

**1. Authority**

This advisory circular is issued under the authority of the chairman of the Instituto de Aviação Civil de Moçambique, in pursuance of powers vested in him under nr 01 of Article 31 of Law 21/2009 of 28 September and point g), Article 12, and the Resolution 19/2011 of 30 November.

**2. Temporary exemption**

IACM decides under what is disposed in MOZCAR Subpart 11.0.3, nr 3, point d) and 11.03.4, nr 1, to concede to ADM, E.P., in favor of Maputo International Airport, Beira International Airport, Nampula International Airport, Pemba International Airport, Tete International Airport and Vilankulos International Airport, temporary exemption to the MOZCAR Subpart 139.16.17 and Subpart IV 4.6. (1), which establishes the certification of International Airports.

**3. Validity**

This exemption has the following validities

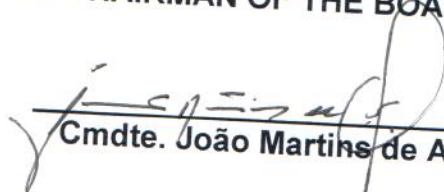
