### **47.02.3 APPLICATION FOR A CERTIFICATE OF AIRCRAFT REGISTRATION**

---

(a) The application shall contain the following information:

- (1) A description of the aircraft that identifies it by reference to its manufacturer, its type and model as designated by its manufacturer, and the serial number given to it by its manufacturer;
- (2) If the aircraft has previously been registered in Mozambique or anywhere else, particulars of the registration,
- (3) Particulars of the registration mark, if it has been reserved for the aircraft;
- (4) The name and address of each person who holds a property interest in the aircraft and a description of the person's property interest;
- (5) The name and address of the registered owner if different from paragraph (4);
- (6) Physical station where the aircraft will be usually stationed;
- (7) Name and signature of the applicant; and
- (8) Date of the application.
